Invoices are payable in full on the terms set forth herein. **All invoices are net 10th of the following month.**

Rentals are invoiced in advance of use.

Invoices will be delinquent if not paid when due. On all delinquent invoices, a finance charge, the maximum allowable by Law, will accrue from the delinquent date.

In the event of any default in payment of the amount due, Buyer will also pay such additional sums as Seller may incur for reasonable attorney's fees and collection costs, whether or not litigation is instigated.

Pursuant to the Uniform Commercial Code in force in Nevada, Seller hereby retains a security interest in the described equipment until payment in full is received.

To secure payment of this invoice, Seller reserves the right to:

- a) Send a Nevada Preliminary Notice to the Owner of the improvement;
- b) Record a Mechanics Lien against the improved property;
- c) Pursue a Mechanics Lien foreclosure action against improved property. The foregoing is not a waiver of Sellers' right to pursue any other remedy at law against Buyer, Owner, or any other party.

DISPUTES: All goods, parts, services, rentals and service labor are hereby deemed accepted by the applicant, and if a dispute occurs it shall be brought to APCO Equipment's attention within 15 days of being invoiced.

Seller will not be responsible for damage to delivery site of Buyer or others arising out of delivery requested by Buyer or others.

In the event of dispute, the Seller and the Buyer hereby agree to submit this matter to mandatory binding arbitration to the American Arbitration Association with the selection of a single arbitrator, the arbitration to be governed by the American Arbitration Association Rules.

In the event that Buyer's check is returned for insufficient funds, Buyer shall pay Seller **\$25.00** for each returned check in addition to replacing the original check.

Seller reserves the right to revoke credit at any time and at its sole discretion.

Buyer hereby authorizes and accepts responsibility for orders placed by persons purporting to act on behalf of Buyer and hereby agrees to be responsible for all charges made by Buyer or Buyers agent unless written notice has been given and received that any person is not authorized to charge on said account.

The undersigned being a principle or corporate officer of the above named company or corporation verify that the information given is freely offered for the purpose of obtaining credit with APCO Equipment.

Full permission is given to investigate the validity of the information through furnished references and available credit and/or financial reporting agencies. APCO Equipment reserves the right to furnish this application to potential lenders.
